*E. Nance motioned to approve updated banking information. K. Millman seconded. Motion carried.*

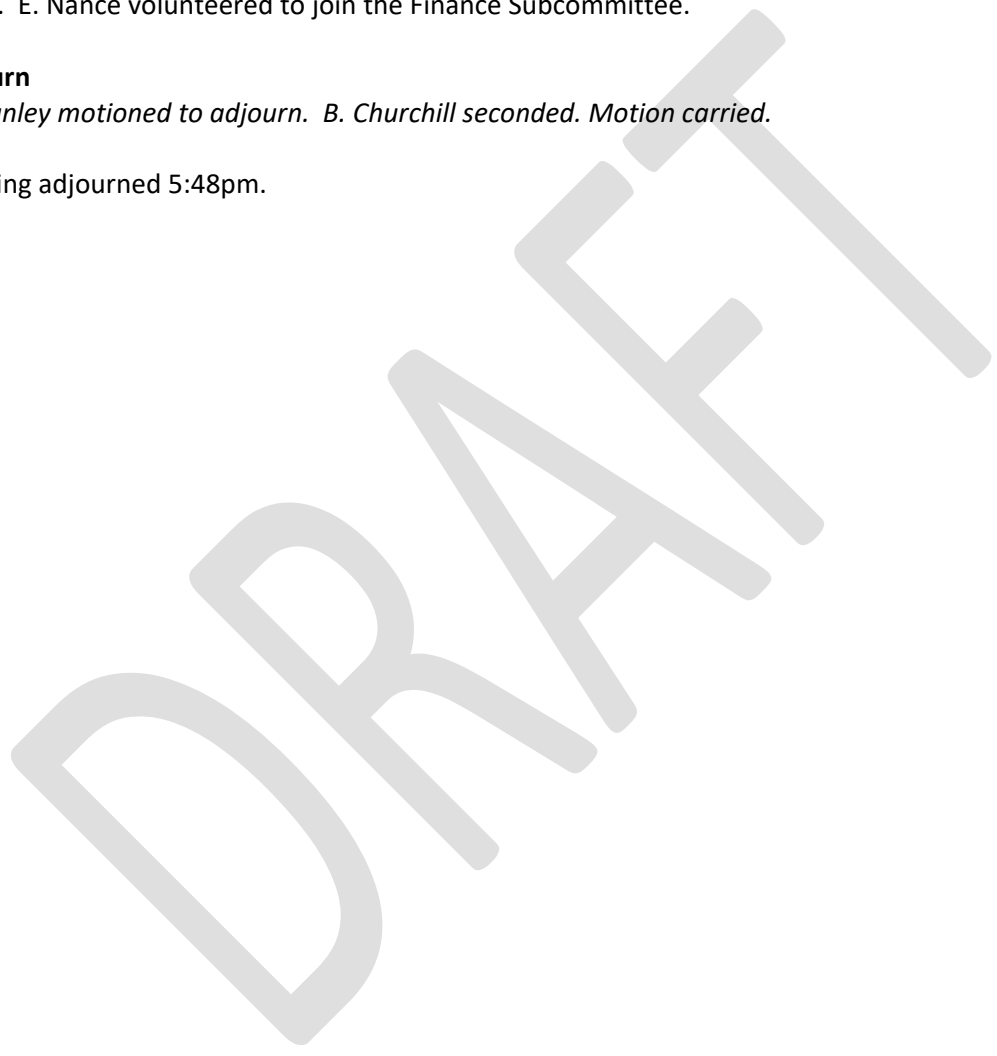
S. Kio announced that staff will be providing an overview course this month for some questions and answers that would be helpful for our newer board members as they might need more insight on our important projects and processes.
